Skateboard park site survey December 2018

History

At its recent Finance Committee meeting Woollahra Council decided to progress its \$1.1million skateboard park project for Rushcutters Bay Park. The skateboard arena was stipulated to accommodate 8-14 year old skateboarders. Now it is designed to accommodate 5-12 year olds apparently.

Council's background notes referred to an examination of other sites. This examination was inadequate and misleading. It failed to thoroughly examine all possible sites within council's own Local Government Area [LGA] or nearby and the two sites it referred to were not properly or adequately assessed.

Councillors were mislead and have not been given the "full menu" of available or possible sites.

This survey remedies those information gaps.

Methodology

This survey has considered every single one of council's 50 open space sites within its LGA. A number were subject of a desk-top study and were eliminated. These included beaches, pools, sloping sites, those with limited physical space, poor access and/or safety concerns etc. The list of the 50 council-controlled public sites was provided by Woollahra Council.

Nine pre-selected potential sites then selected. These were inspected individually by two people on Saturday 22nd December 2018 with corroborated notes and photos taken on-site. This desk-top and on-site surveys initially considered the following 50 sites including an additional state-government-owned site in William Street, East Sydney:

The following nine criteria were used to assess site suitability:

- 1. size, ie., above 1,200 square metres
- 2. general location
- 3. proximity to public transport
- 4. car parking drop-off and pick-up availability for young children
- 5. room for observation seats
- 6. local safety
- 7. proximity to residences
- 8. conflicting other activities and
- 9. potential adverse acoustic impacts.


