<i>Comment:</i>	<ul style="list-style-type: none"> • Woollahra net additional dwellings target 2016 to 2036 is 1,200. We have already delivered 889. We only need to deliver 311 in the next 15 years, which will happen organically. We don't have a housing problem. We have an overdevelopment problem. We don't need another 1,250 dwellings in Edgecliff. • I voted to put the Edgecliff corridor on exhibition so that the community could have their say. I voted to extend the exhibition period (but lost). I am waiting for the results of the community consultation so I can understand residents' opinions and advocate and vote accordingly. • Personally, I think the design and façade of New South Head Road, Edgecliff and New Maclean Street could be improved, but I am not in favour of high-rise; I am strongly opposed to 26 storey buildings. • I believe Woollahra Council and the elected Councillors should be responsible for development in our municipality and I am extremely concerned about the growing influence of unelected planning panels.

<p><i>Comment:</i></p>	<ul style="list-style-type: none"> • All 15 Councillors did not vote to go ahead with building this facility. This proposal was reviewed by the FC&S Committee. I, like six other Councillors, were not on this committee, so we never actually voted on it at all. • The allocated funds were a grant from the State Government. • Due to the heritage listing of the park, a heritage impact assessment will have to come back before Council. If and when that happens (it may prove all too hard), and if the assessment proposes moving forward with the planned facility, then, in light of the heritage listing and the fact that most local residents now seem to oppose it, I will not be supporting it. • I also oppose cutting a hole in the Yarranabbe heritage listed wall and always have opposed this.

- I think the signs could be more aesthetic; I'm not sure about the red or the NOT in capitals.
- But we really need to eradicate this blight upon our society and we in the Eastern Suburbs need to do our bit.
- Only last week in Bondi a prominent rugby league player was allegedly accused by the NRL of a racial slur against a lady of Vietnamese heritage.
- Luise Elsing put forward this motion, which was unanimously supported by Councillors, and has written brilliantly on the topic:

"This initiative is in response to a situation I witnessed in the LGA consistent with an increase in anti-Asian, anti-Muslim and anti-Jewish sentiment in NSW since COVID (and more recently the change of relationship with China). And I have had feedback that the experience was not a one off. It is refreshing that people in the area feel there is no racism in the LGA but this is not every one in the LGAs experience, which the research supports (links below to just a few).

This programme of signage has been effective in other LGAs and the resolution reflects that Woollahra Councillors unanimously want to do something and not stand by and be inactive in the face of a rising trend around racism. I totally understand concerns about too much signage and bold signage but note that there are handful of signs throughout the LGA and their point is to attract attention to the issue. If the signs constrain perpetrators and empower bystanders, then the signs would have been worth it.
